


#### Use of tax treaty database when drafting the national model

  - Comparing individual DTAs (<u>link</u>)





### **Comparison DTAs Netherlands - Malawi and Netherlands - Kenya**






Both DTAs have been signed in 2015 but are not yet effective (LINK)



### **Comparison DTAs Netherlands – Ghana and Netherlands – Kenya**




